

# **ANTI-CORRUPTION POLICY**

#### 1. Purpose

Transcend Solutions Pte Ltd (hereafter referred to as "the Company") is committed to conducting its business with integrity and in compliance with all applicable laws and regulations. Corruption in any form undermines this commitment and is strictly prohibited by the Company. This Anti-Corruption Policy outlines the standards and procedures to prevent corruption and bribery in all aspects of our operations.
